Terms of Agreement:

All transactions between Hunter Wine Marketing ("Seller") and the account ("Purchaser") shall be conducted in accordance with the rules and regulations of the State of California's Alcoholic Beverage Control Commission ("ABC"). This includes, but is not limited to, all invoices being payable and due in full 30 days from date of delivery (except where otherwise stated as part of a special offer). A non-refundable \$20 fee is charged for any and all returned checks. We are also required by the ABC to place any account with an outstanding balance of more than 30 days on a C.O.D. basis, and under ABC rules, we must begin to charge interest of 1.5% per month (18% annum) on any and all balances greater than 42 days overdue, and again each 30 days thereafter, as mandated by state regulation. The seller reserves the right to limit any account's credit limit and in the event a Purchaser is turned over to an attorney or other agency (including the courts of the State of California) for collection, the Purchaser hereby agrees to pay any and all reasonable costs incurred by the Seller. The Purchaser also agrees to accept the jurisdiction of San Mateo County, should any court action be deemed necessary. Seller may alter or change these credit terms without prior notice at any time, so long as they remain within the regulations of the ABC. By providing my signature below, I understand the California Office of Environmental Health Hazard Assessment (OEHHA) adopted new **Proposition 65** warning requirements that took effect on August 30, 2018.
